Appropriations Update

Congress returns to Washington on December 1 and will have just 10 days to reach agreement on FY15 spending before the existing Continuing Resolution (CR) runs out.

Sources close to the House Appropriations Committee indicate appropriators are close to

agreement on a funding mechanism for FY15. According to Jennifer Hing, a spokesperson for the House Appropriations Committee, “Negotiations with the Senate continue, and the committee has made significant progress on a full year, 12-bill omnibus. We expect to have the bill read for the floor the week of December 8. Congress wants to avoid a government shutdown.

The measure is being dubbed a “CRomnibus” and will include two parts: an omnibus that will fund all 12 spending bills through September 2015 and a short-term CR that will fund immigration enforcement partially through 2015. The short-term funding for immigration enforcement is intended to appease those Republicans who are livid with President Obama for issuing an executive order that ends deportation for millions of undocumented immigrants. The CR will give the GOP time to consider legislation to address the executive order, which conservatives deem unconstitutional.

CDBG Coalition Sends H. Res. 668 Support Letter

On November 19, the CDBG Coalition sent a letter to House leadership and members of the House Financial Services Committee to ask for their support in moving H. Res. 668 (supporting the 40th anniversary of CDBG), to the House floor under suspension of the rules before this session of Congress ends. The resolution was on target to be moved to the House floor in September, but Congress left town early to focus on the mid-term elections, leaving little time now for this and other resolutions and legislation to be voted on before this session of Congress ends. 114th House Cardinals Announced

Last week, the House Republican Steering Committee approved the following appropriations subcommittee chairs (or “Cardinals”). Rep. Hal Rogers (R-KY) will retain the post of chair of the House Appropriations Committee. Rep. Mario Diaz-Balart (R-FL) will take over the chairmanship of the Transportation-HUD Subcommittee from Rep. Tom Latham (R-IA) who is retiring. While Rep. Diaz-Balart is a friend of CDBG, he and the other appropriations cardinals will have to operate under strict budget caps imposed by the House Budget Committee that will force cuts to many programs.

On the minority side, Nita Lowey (D-NY) will retain her position as ranking member of the Committee. Democrats will finalize the Appropriations Committee ranking member positions in January.

Census Bureau Webinar on the American Community Survey Scheduled for December 1

The U.S. Census Bureau will host a webinar to discuss the upcoming release of the latest American Community Survey statistics covering communities of all sizes. The release includes detailed data for the five-year period between 2009-2013. The webinar will provide guidance on using and comparing the statistics, describe new and modified data tables, and demonstrate how to access block-group-level data in American FactFinder – available in American FactFinder for the first time with this release.

The webinar will be held on December 1, 2014 at 1 pm EST. The webinar will be conducted via conference call and online presentation. To access the webinar, call 1-888-324-3810. HUD Releases Notice on Use of CDBG Funds for Code Enforcement Activities

HUD has issued a notice, CPD-14-016, on the use of CDBG funds for code enforcement activities. The notice covers the following topics: HUD's definition of code enforcement, purpose of code enforcement, eligible code enforcement costs, ineligible code enforcement costs, national objectives for code enforcement, fair housing and civil rights considerations, revenue from code enforcement inspections and enforcement of codes, 2012 statutory provision on code enforcement, and recordkeeping requirements. HUD Launches Financial Management Curriculum for CPD Grantees

HUD's Office of Community Planning and Development recently launched a three-tiered, online curriculum on financial management. The curriculum includes an introductory video, a presentation on the core concepts of good financial management, and a self-paced module that provides more detail on core financial management topics such as audits, budgeting, federal cost principles, fund accounting, internal controls, reporting, and procurement. A quiz is offered at the end of the training curriculum.

HUD Releases Section 811 and Section 202 Rule; Comments Due by December 8

On October 9, 2014, HUD released a proposed rule outlining several changes to the Section 811 Supportive Housing Program for Persons with Disabilities and the Section 202 Supportive Housing Program for the Elderly. Major changes include the following:

1. Provides funding to state housing finance agencies for rental assistance to extremely low income non-elderly adults with disabilities.
2. Implements an enhanced project rental assistance contract (ePRAC) that would allow operating subsidies to pay debt service under certain circumstances.
3. Allows for a set-aside of a certain number of units in projects for elderly persons with functional limitations.
4. Implements a new form of rental assistance called the Senior Preservation Rental Assistance Contracts (SPRACs) to be used in the refinancing of Section 202 projects where no debt service savings are anticipated and where unassisted residents would otherwise face rent increases.
5. Provides grants for applicants that do not have sufficient capital to prepare a housing site to compete for funding.

NCD A and NACCED Submit Joint Comment Letter on Fair Housing Notice

Over the past six weeks, NCD A and NACCED have worked together to craft a response to HUD’s Affirmatively Furthering Fair Housing Assessment Tool Notice (FR 5173-N-02), issued on September 26. The NCD A/NACCED letter is endorsed by the U.S. Conference of Mayors. NCD A would like to thank those members who participated in the working group and/or provided separate comments.

The Notice will have a profound impact on local communities administering CDBG, HOME, ESG, and HOPWA; as well as their PHA partners. The Notice will require a separate citizen participation process and data collection effort from that of the Consolidated Plan which will result in additional staff time and cost for local communities. The following provides a synopsis of the NCD A/NACCED letter.

1. We ask HUD to table both the Affirmatively Furthering Fair Housing Final Rule (expected to be issued in the next couple of months) and the Affirmatively Furthering Fair Housing Assessment Tool Notice until the U.S. Supreme Court has ruled on the legality of HUD’s disparate impact regulations (issued in February 2013). The disparate impact regulations form the basis for much of the rule and the notice. The U.S. Supreme Court is expected to hear the case *Texas Department of Housing and Community Affairs v. Inclusive Communities Project, Inc.* early next year.
2. We strongly recommend that the Assessment of Fair Housing (AFH) Tool be a component of the Consolidated Plan rather than a free-standing pre-requisite for submitting the Consolidated Plan.
3. We ask HUD to change the CDBG program statute to allow fair housing to be a direct eligible activity rather than funded through the 20% planning and administration cap. Since a statutory change will take time to implement, we ask HUD to provide grants to

CDBG entitlement communities in the FY16 HUD budget to help pay for the costs of developing the initial AFH Tool.

4. We ask HUD to scale back the fair housing data and analysis process for smaller entitlements.
5. We advise HUD that grantees will need time to review and test the HUD-provided data elements.
6. We ask HUD to provide program participants with guidance on how the AFH Tool will be reviewed and assessed; a checklist for grantees to follow would be useful.
7. We recommend that the AFH Tool be approved by the Office of CPD within HUD headquarters since there is no consistency among field offices.
