### Appropriations

- FY2020 Corrections
  - CDBG and HOME Programs
  - CDBG-CV Round 1 Remedied in Round 3
- CARES Act CDBG-CV \$5 Billion (Up to 3 Rounds One Grant)
- FY21 Numbers Community Development Fund
  - CDBG \$3.475 Billion (Around 25 February 2021)
  - Recovery Housing Program \$25 Million (CD Fund)
  - Section 108 Loan Guarantee Authority \$300 Million





## Appropriations (Cont.)

- FY21 Numbers
  - Homeless \$3 billion
  - HOME \$1.35 billion

- DR Grants
  - Grant Numbers with a B-13 (Sandy Funds) statutory deadline for closeout is now 30 September 2023


