U.S. Department of Housing and Urban Development

2020 and 2021

- HOME: \$1.35 billion
 - Same as 2020
- Allocations must be announced by February 25th
 - Allocations should be close to corrected 2020 allocations
- Unit production down 23% in FY 2020
 TBRA households down 9%

For over 20 years, the HOME Investment Partnerships Program (HOME) has provided formula grants to states and localities that communities use to fund a wide range of activities including constructing, acquiring, and/or rehabilitating affordable housing for rent or homeownership or providing direct rental assistance to low-income households. HUD is showcasing exemplary projects or programs for each of these HOME activity types: rental, homebuyer, homeowner rehabilitation, and tenant-based rental assistance. These projects or programs are innovative and/or replicable, and highlight the best of what partnerships between federal, state, local governments and communities can achieve with HOME funds.

Section 3 Final Rule

- Published September 29, 2020
- Final Rule can be found at 24 CFR 75
- Makes significant changes to the 1994 Interim Rule (24 Part 135)
- Better aligned with statutory priorities
- Reduced administrative burden

Section 3 Final Rule

- Definition of a Section 3 project
 - HUD funds for housing rehabilitation, housing construction, or other public construction projects that exceed a \$200,000
 - Funds from HUD's Lead Hazard Control and Healthy Homes programs
- Reporting on labor hours worked
 - Total labor hours worked on a Section 3 project, by
 - Section 3 workers, Targeted Section 3 workers
 - Better aligns with standard business practices
 - Departure from measuring new hires

Section 3 Final Rule

- Final Rule effective on November 30, 2020
 - Requirements of old rule no longer in effect
 - PJs must begin following Part 75
- Compliance date: July 1, 2021
 - Section 3 projects required to follow the reporting requirements in 24 CFR 75.25
 - Report in IDIS
 - Not required to report on projects committed or completed between 11/30/2020 and 7/1/2021
 - Keep files associated with Section 3 Projects that occurred during transition period

 - Statutory Suspensions and Regulatory Waivers to Facilitate Provision of HOME Tenant-Based Rental Assistance to Households Affected by COVID-19 Pandemic
- December 4, 2020
 - Revision, Extension, and Update of April 2020 Memo Availability of Waivers and Suspensions of the HOME Program Requirements in Response to COVID-19 Pandemic
 - Revision and Extension of April 2020 Memo Suspensions and Waivers to Facilitate Use of HOME-Assisted TBRA for Emergency and Short-term Assistance in Response to COVID-19 Pandemic

General HOME COVID Waivers Revision, Extension and Update

NEW:

- Suspension and Waiver of Maximum Per Unit Subsidy Limit
 - Projects currently underway or in the planning stages (but committed prior to end of extended waiver period)
- Source Documentation for Income Reexaminations – Tenant Income

General HOME COVID Waivers Revision, Extension and Update

REVISED

- Income Documentation
- Initial and Annual Inspection of TBRA Units
- 4-Year Project Completion Deadline
 HOME funds for Operating Reserve

General HOME COVID Waivers: Extensions, Revisions & Updates

EXTENDED

- On-Site Inspections of HOME-assisted Rental Housing
- Nine-Month Deadline for Sale of Homebuyer Units
- Timeframe for a Participating Jurisdiction's Response to Findings of Noncompliance

TBRA for COVID Response Extensions, Revisions & Updates


REVISED

- Eligible Tenant-based Rental Assistance Costs and Maximum TBRA Subsidy
- Tenant Protections Lease
- Housing Quality Standards
- Annual Inspection of Units Occupied by Recipients of HOME TBRA
 Income Determination

TBRA for COVID Response Extensions, Revisions & Updates

EXTENDED

- Rent Reasonableness
- Eligible Tenant-based Rental Assistance Costs and Maximum TBRA Subsidy
- Term of Rental Assistance Contract
