General HOME COVID Waivers Revision, Extension and Update

NEW:

- Suspension and Waiver of Maximum Per Unit Subsidy Limit
- Projects currently underway or in the planning stages (but committed prior to end of extended waiver period)
- Source Documentation for Income Reexaminations – Tenant Income





General HOME COVID Waivers Revision. Extension and Update

REVISED

- Income Documentation
- Initial and Annual Inspection of TBRA Units
- 4-Year Project Completion Deadline
- HOME funds for Operating Reserve





General HOME COVID Waivers: Extensions. Revisions & Updates

EXTENDED

- On-Site Inspections of HOME-assisted Rental Housing
- Nine-Month Deadline for Sale of Homebuyer Units
- Timeframe for a Participating Jurisdiction's Response to Findings of Noncompliance – 24





TBRA for COVID Response Extensions. Revisions & Undates

REVISED

- Eligible Tenant-based Rental Assistance Costs and Maximum TBRA Subsidy
- Tenant Protections Lease
- Housing Quality Standards
- Annual Inspection of Units Occupied by Recipients of HOME TBRA
- Income Determination


