

NCDA Washington Report December 19, 2019

Appropriations Update; FY20 Spending Bills Close to Being Enacted; CDBG and HOME Receive Funding Increases

Congress is on track to approve all 12 spending bills by December 20, the date the current continuing resolution expires. The bills are being packaged into two "mini-bus" bills. One package contains four bills -- Defense, Homeland Security, Commerce-Justice-Science and Financial Services. The second package contains the remaining eight spending bills, including the Transportation-HUD (THUD) spending measure. Our core programs – CDBG, HOME, and HUD's Homeless Assistance Grants – all received funding increases. Because of the work of the CDBG Coalition, HOME Coalition, and grantees, CDBG and HOME both received their highest funding levels since FY11.

<u>Highlights</u>

- \$3.425 billion for CDBG, \$100 million increase in formula grants from FY19. An additional \$25 million is provided for a state pilot program providing supportive housing for persons recovering from substance abuse.
- \$1.35 billion for HOME, \$100 million increase in formula grants from FY19
- \$2.7 billion for HUD's Homeless Assistance Grants, \$141 million increase from FY19; \$80 million of these funds will be targeted to youth homelessness
- \$410 million for the Housing Opportunities for People with AIDS (HOPWA) program, \$18 million increase
- \$300 million for Section 108, level funding from FY19
- \$202 million for the Section 811 Housing for People with Disabilities Program, \$80 million increase
- \$793 million for the Section 202 Housing for the Elderly Program, \$115 million increase
- \$2.869 billion for the Public Housing Capital Fund, an increase of \$94 million from last year
- \$4.549 for the Public Housing Operating Fund, a decrease of \$104 million
- \$12.5 billion for project-based rental assistance to renew all contracts
- \$23.8 billion for Housing Choice Vouchers, including \$21.5 billion for existing contract renewals
- \$25 million to maintain the Housing Choice Voucher Mobility Demonstration Program to assist lowincome families with children move to higher opportunity neighborhoods
- \$290 million for the Office of Lead Hazard Control and Healthy Homes programs, increase of \$11 million

In addition, the spending bill includes language suspending the 24-month commitment deadline in the HOME Program through 2022, including for Community Housing Development Organizations (CHDOs). The National Flood Insurance Program would be extended through September 30, 2020 and the New Markets Tax Credit would be extended for another year.

Disagreement over funding of the border wall was the main item that delayed Congress in reaching a final agreement. In the end, the Administration and Congress agreed to leave border wall funding static at \$1.4 billion rather than provide \$8.6 billion as the President had requested. The deal does not stop President Trump from

shifting funds from other programs to pay for border wall funding as has happened in past years with the siphoning of billions from military construction projects.

Federal Agencies Plan Overhaul of the Community Reinvestment Act

On December 13, the Federal Deposit Insurance Corporation (FDIC) and the Office of the Comptroller of the Currency (OCC) issued a joint notice of rulemaking to amend the Community Reinvestment Act (CRA). The FDIC and the OCC are accepting public comments on the proposal until 60 days after it is published in the Federal Register, which is expected to be shortly.

Enacted in 1977, the CRA requires lending institutions to provide credit and make investments in low- and moderate-income neighborhoods. The OCC issued an advanced notice of proposed rulemaking in August 2018 seeking recommendations for modernizing the CRA. According to the OCC, most of the commenters did not like the current CRA regulatory framework, saying it lacked objectivity, transparency, and fairness. In response to this feedback, the OCC and FDIC issued this joint notice of rulemaking to outline their proposal for strengthening the CRA regulatory framework. One of the more controversial proposals in the notice is the recommendation to change the rating system for community development investments. Under the current CRA evaluation rules, community development investments, including affordable housing investment, count for 25% of the entire CRA rating. The new proposal would eliminate this percentage and include community development investments as an overall goal in the evaluation process, which could lead to less investment in affordable housing activities.

Funding Available to Provide Housing Assistance to Victims of Human Trafficking

The Department of Justice announced the availability of \$13.5 million in grants to provide housing assistance and supportive services to victims of human trafficking. States, units of local governments, and organizations are eligible to apply for the funding.

The funds can be used to support the following activities:

- Transitional housing (including operating expenses) to help transition into permanent housing
- Short-term housing assistance, including rent, security deposits, utilities, relocation costs
- Projects must also provide support services to help human trafficking victims locate permanent housing and employment

URA Proposed Rule Released

The U.S. Transportation Department has released a <u>proposed rule</u> to amend and update regulations (49 CFR Part 24) pertaining to the Uniform Relocation Assistance and Real Property Acquisition Policies Act of 1970 (Uniform Act). Planned revisions to the regulations include increasing relocation benefits, reducing the length of occupancy requirements, and streamlining the regulations. Comments are due on March 17, 2020. HUD Housing Counselor Certification Deadline is August 1, 2020

HUD issued a <u>final rule</u> on December 14, 2016 that requires that housing counseling provided in connection with HUD programs (including CDBG and HOME) be provided by HUD-certified housing counselors. Housing counseling staff must be certified as a HUD Housing Counselor by **August 1, 2020**. Please go <u>here</u> for information on the certification process.

Start Planning for National Community Development Week – April 13-18, 2020

Congress recently approved increased funding for CDBG and HOME in the FY20 spending bill. This was the result of months of advocacy by the CDBG and HOME coalitions, and your efforts during National Community Development Week. We will seek further increased funding for the programs in FY21 and it is important that all NCDA members participate in the 2020 National Community Development Week effort.

National Community Development Week is only four months away, so the time to start planning is now. The sole purpose for National Community Development Week is to educate members of Congress and local officials on the impact of the CDBG and HOME programs locally and the *need* for more funding. It is important that you reach out to your Congressional offices now to seek their participation in National Community Development Week.

This year we are asking members to focus on two primary activities: (1) projects tour; and (2) meeting with Congressional district offices.

Projects Tour

- Focus on areas that need CDBG/HOME investment. This will help make the case for increased program funding.
- Tour one or two CDBG/HOME funded projects to show the results of the programs.

District Office Meetings

• Reach out to your Congressional members to arrange a meeting at their district office during National Community Development Week.

Contact congressional offices in January. Start by calling your local district office - phone numbers for district offices are available on the legislators' web sites (see below). Some offices schedule exclusively through their DC office, so you may need to make several calls before you get in contact with the appropriate scheduler. Ask the scheduler what is required by the office to submit a formal invitation for your Congressional member to participate in the projects tour. The scheduler can also arrange a meeting for you at the district office.

Follow-up frequently. Schedulers are extremely busy and are constantly inundated with requests. Make sure yours gets the proper attention by contacting the scheduler frequently - initially twice a week but increase that to daily in the two weeks leading up to the event if you still have not received an answer. Make sure you ask the staffer handling your request what the best way to get in touch with him/her is and use those communication methods. If you are having trouble getting in touch with the person handling your request, leave messages with the office receptionist, too.

Don't get discouraged if members of Congress or their staff cannot attend your event. Work with the office on alternative ways they can participate - ask if they can issue a press release about your event, promote it on social media, or begin a scheduling request for a district work period later in the year. They may have other ideas on how they can participate, so be flexible.
